

JCK Las Vegas 2017 Exhibitor Lead Retrieval Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER:

(a) JCK Las Vegas 2017 Exhibitor Lead Retrieval Sweepstakes Entry.

The sweepstakes begins on Monday, June 5, 2017 at 8:00 AM and ends 5:00 PM on Thursday, June, 8 2017. (the "Sweepstakes Period").
