

2019 JCK Las Vegas Lady Gaga Sweepstakes
(the “Sweepstakes”)
Official Rules

1. HOW TO ENTER:

(a) 2019 JCK Las Vegas Lady Gaga Sweepstakes Entry. The Sweepstakes begins at 12:00 AM PT on Monday, November 19, 2018 and ends at 11:59 PM PT on Saturday, June 1, 2019 (the “Sweepstakes Period”). During the Sweepstakes Period, eligible participants may enter the Sweepstakes by booking a room within the block of rooms made available by Sponsor in the Venetian Resort in Las Vegas, NV, in connection with the 2019 JCK Las Vegas show (the “Show”) within the Sweepstakes Period. All entries must be received during the Sweepstakes Period. Pacific Time shall control for all purposes of this Sweepstakes. Sponsor's clock shall be the official timekeeper for the Sweepstakes. The Sweepstakes is governed by these official rules and is subject to all applicable U.S. federal, state and local laws. This Sweepstakes is void where prohibited. By entering, each participant in this Sweepstakes assumes all risk incidental to participation in in the Sweepstakes.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

(b) Limit one entry per person, per email address. Multiple entries are not permitted. Entries by the same person in excess of the limits stated herein will be disqualified. In the event of a dispute over the identity of an entrant, an entry will be deemed submitted by the authorized account holder of the email address associated with the email account connected with the entry at the time of entry. “Authorized account holder” is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted email address. 2. PRIZES:

One (1) grand prize winner will be awarded two (2) tickets for Lady Gaga’s Jazz and Piano Show at the Park MGM for the 8PM, Sunday June 2, 2019 performance (the “Prize”) (the total estimated retail value of the Prize is US\$2,000.00). The Prize does not include any travel expenses, personal expenses, or any other costs not specifically described in these Official Rules as included in the Prize and will be the responsibility of the winner and his/her guest(s). All expenses on receipt and use of Prize are the sole responsibility of the winner. In the event that the Prize or any part of the Prize become unavailable, for any reason whatsoever, winner agrees that the Sponsor and its agents shall have no further obligations, other than to deliver the remainder of the Prize. If any winner, or winner's guest, are unable or unwilling to accept or participate in any part of the Prize, that portion of the Prize will be deemed as forfeited by

such winner and no substitution will be made except at Sponsor's sole discretion. Any portion of the Prize unclaimed or unused by the winner will be forfeited and will not be substituted. 3. WINNER SELECTION:

A total of one (1) winner will be selected by Sponsor in a random drawing occurring on Sunday, June 2, 2019 from all eligible entries received in the Sweepstakes Period prior to the drawing date. The drawing will be conducted by Sponsor, whose decisions are final and binding on all matters relating to this Sweepstakes. Winners need not be present to win. Odds of winning are dependent upon the total number of eligible entries received. Sponsor will attempt to notify the potential winners by e-mail, by text message, or by phone call on June 2, 2019. The potential winner will have one (1) hour from receipt of such notification to claim their Prize by emailing their full name and email address (and proof of eligibility if requested) or as otherwise noted by Sponsor in the notification. After claiming the Prize, the potential winners will receive instructions on redeeming their Prize. Sponsor reserves the right, in its sole discretion, to not select a winner(s) if an insufficient number of eligible, complete, appropriate or generally qualified entries are received.

Each potential winner and their guest(s) may be required, in Sponsor's discretion, to execute and return an Affidavit of Eligibility, Release of Liability, and Publicity Release within ten (10) days of notification attempt or the Prize will be forfeited and an alternate winner selected. Sponsor is not responsible for disclosures made by any third party.

eligible to enter or win. Registered exhibitors at the Show, and their immediate family and household members, are not eligible to enter or win.

If Sponsor determines, in its sole discretion, that technical difficulties or unforeseen events compromise the integrity or viability of the Sweepstakes, Sponsor reserves the right to void the entries at issue, and/or terminate the relevant portion of the Sweepstakes promotion, including the entire Sweepstakes promotion, and/or modify the Sweepstakes and/or award the Prize based upon the criteria set forth in these Official Rules from all eligible entries received as of the termination date.

No responsibility is assumed for: any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, providers, computer equipment, or software; or failure of any e-mail or electronic entry to be received on account of technical problems or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to entrant's or any other person's computer or other device or the contents thereof related to or resulting from participation in or downloading any materials from this Sweepstakes.
