2021 JCK LAS VEGAS MATCHMAKING SPIN SWEEPSTAKES (the "Sweepstakes") Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

This Sweepstakes is being held in connection with JCK Las Vegas 2021 at the Sands Venetian in Las Vegas, NV, scheduled to take place from August 27, 2021 through August 30, 2021 (the "Event").

- **1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at 9:00AM (PT) on August 27, 2021 and ends at 3:59PM (PT) on August 30, 2021 (the "Sweepstakes Period").
- **2. HOW TO ENTER:** Each person who (i) enters the Sweepstakes and (ii) meets the eligibility requirements as described in Section 6 herein shall be referred to as a "Participant". During the Sweepstakes Period, eligible Participants may enter the Sweepstakes by downloading the Event app and receiving a list of "JCK Match" exhibitors who are at the Event. Simply visit the JCK Match Prize Wheel on-site at the Event and present proof that the Event app has been downloaded and your "matches" were viewed and Participant will be entitled to one (1) spin of the JCK Match Prize Wheel, as described below.

Limit one entry (e.g., one "spin") per Event day per Participant. Multiple entries from the same Participant are not permitted. Entries by the same Participant in excess of the limits stated herein will be disqualified. Entering or attempting to enter the Sweepstakes multiple times for a single individual is prohibited and will be deemed void and disqualified.

All entries must be received during the Sweepstakes Period. Pacific Time shall control for all purposes of this Sweepstakes. Sponsor's clock shall be the official timekeeper for the Sweepstakes. In the event of a dispute over the identity of a Participant, an entry will be deemed submitted by the authorized account holder of the email address associated with an Event registration. "Authorized account holder" is defined as the natural person who is assigned to the account by the applicable online service provider or organization.

3. PRIZES: On each day of the Sweepstakes Period, Participants will be entitled to one (1) spin on a prize wheel (the "JCK Match Prize Wheel") located at the JCK Match Booth onsite at the Event. Each Participant is entitled to only one (1) spin on the JCK Match Prize Wheel for each day of the Event and no Participant may spin the JCK Match Prize Wheel more than one (1) time each on each day of the Sweepstakes Period. Limit one Prize per Participant/household. Sponsor reserves the right to cease use of the JCK Match Prize Wheel on any given day of the Sweepstakes Period if all of the Prizes allocated for that day have already been distributed. All Prizes are offered on a first-come first-served basis and supplies of the Prizes are limited. Once the supply of a type of Prize has been depleted, Sponsor shall reserve the right to substitute another Prize. Once all Prizes have been claimed, the Sweepstakes shall automatically end.

No substitutions may be made for any Prize (or portion of a Prize), except that, in the event that any Prize (or portion of a Prize) becomes unavailable for any reason whatsoever or becomes unreasonably difficult to fulfill, Sponsor reserves the right to substitute such Prize (or portion of a Prize) for one of equal or greater value. If any winner (or winner's guest(s), as applicable) is unable or unwilling to accept or participate in any part of a Prize, that portion of the Prize will be deemed as forfeited by such winner (or winner's guest(s), as applicable) and no substitution will be made except at Sponsor's sole discretion. Failure to take delivery of any Prize may result in forfeiture, and such Prize being awarded to an alternate winner. Any portion of a Prize unclaimed or unused by a winner will be forfeited and will not be substituted. Cash redemptions for Prizes shall not be allowed, except at Sponsor's sole discretion.

Any Prizes that may be depicted in advertising, promotional, or other Sweepstakes materials are for illustrative purposes only. The actual Prize may vary. In the event there is a discrepancy or inconsistency between the description of a Prize contained in any promotional materials and the description of a Prize contained in these Official Rules, these Official Rules shall prevail, govern and control. 4. WINNER SELECTION: On each day of the Sweepstakes Period, a total of one hundred ten (110) winners will be selected at random through their spins on the JCK Match Prize Wheel. All spins of the JCK Match Price Wheel will be overseen and conducted by Sponsor, whose decisions are final and binding on all matters relating to this Sweepstakes. Winners must be present to win. Odds of winning are dependent upon the total number of Participants and of eligible entries received. Sponsor will notify potential winners immediately in the JCK Match Booth. The potential winners will either receive their Prize immediately or receive instructions on redeeming their Prize. Sponsor reserves the right, in its sole discretion, to not select a winner(s) if an insufficient number of eligible, complete, appropriate or generally qualified entries are received.

Each potential winner (and each of winner's guest(s), as applicable) may be required, in Sponsor's discretion, to execute and return an Affidavit of Eligibility, a Release of Liability, a Publicity Release, required payment information or tax forms, and/or proof of identification and eligibility (collectively, the "Winner Forms"), each as requested by Sponsor. If a Participant fails or refuses to sign and return all of the Winner Forms provided by Sponsor within ten (10) days (or a shorter time if required by exigencies) after receiving them, the Participant may be disqualified resulting in forfeiture of the Prize, and Sponsor reserves the right, but not the obligation, to select an alternate winner.

Sponsor reserves the exclusive right to address and resolve any aspects of the Sweepstakes or incidents that affect the Sweepstakes that may not be expressly outlined in these Official Rules, and any such decisions shall be final and binding and not subject to challenge or appeal. Except as otherwise expressly set forth herein, all of Sponsor's rights pursuant to these Official Rules relate to and are exercisable against all Participants as a whole and against each individual Participant.

If there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules will prevail, govern and control. Neither the failure of Sponsor to insist upon or enforce strict performance of any provision of these Official Rules nor the failure, delay or omission by Sponsor in exercising any right with respect to any term of these Official Rules, will be construed as a waiver or relinquishment to any extent of Sponsor's right to assert or rely upon any such provision or right in that or any other instance.

The invalidity or unenforceability of any provision in these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Headings and captions are used in these Official Rules solely for convenience and ease of reference and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof.

6. ELIGIBILITY: This Sweepstakes is open only to Participants who, at the time of entry, are (i) at least eighteen (18) years of age or the age of majority in their jurisdiction of residence, whichever is greater; (ii) the holder of a valid, registered and activated badge (or ticket, wristband or other authorized means of entry) to the Event; (iii) in attendance at the Event during the Sweepstakes Period; and (iv) owners of a mobile phone or other device capable of installing the Event mobile app. All Participants must be able to provide proof of identification and eligibility if requested by Sponsor.

Employees of RELX Inc. and each of its parents, subsidiaries, divisions, affiliates, and advertising or promotional agencies, and the immediate family and household members of all such individuals, are not eligible to enter or win. Registered exhibitors at the Event, and their immediate family and household members, are not eligible to enter or win.

Please note that non-U.S. Participants may be subject to laws or regulations within their respective jurisdictions of residence that may restrict or limit their ability to participate in the Sweepstakes and/or to receive or accept Prizes. Non-U.S. Participants whose jurisdiction of residence prohibits its residents from participating in sweepstakes in the U.S. are not eligible. All such costs shall be

borne solely by the Participant, and Sponsor will not be held liable for any costs associated with Participant's participation in the Sweepstakes.

- 7. USE OF DATA: Each Participant's information will be collected and used by Sponsor in accordance with the Privacy Policy (the "Privacy Policy") posted on https://privacy.reedexpo.com/en-us.html, which is incorporated herein by this reference. By entering the Sweepstakes, each Participant agrees and acknowledges that he or she has read, understood and agrees to be bound by (i) these Official Rules; and (ii) the Privacy Policy, each as may be amended by Sponsor. All Participants are expected to review the Privacy Policy carefully before participating in the Sweepstakes and each Participant acknowledges that, in the event of a conflict or inconsistency between the terms of these Official Rules and the terms of the Privacy Policy, the terms of the Privacy Policy shall prevail, govern and control. In addition, Sponsor may engage third party entities to administer certain aspects of the Sweepstakes, including without limitation, the collection of Participant information. Notwithstanding anything to the contrary in the Privacy Policy, Sponsor may share Participant's information with third party entities to the extent needed to perform their duties and functions in connection with the Sweepstakes or otherwise in accordance with their own independent privacy practices.
- **8. PUBLICITY:** Except where legally prohibited, a winner's acceptance of a Prize constitutes such winner's grant of permission (and agreement to confirm such grant in writing) for the Released Parties to use such winner's name, voice, likeness, photograph, video, testimonials, biographical information, and/or statements made by winner in all media now known or hereafter discovered, worldwide without additional notice, approval, or compensation and in perpetuity. Each winner's name may be included in a publicly available winners list.

LIMITATION ON LIABILITY; FORCE MAJEURE: Each Participant agrees that Sponsor shall not be responsible or liable for, and are hereby released from, any and all claims, costs, injuries, losses or damages of any kind, relating to any of the following: (a) incomplete, inaccurate, lost, late, misdirected or illegible entries, winner notifications, Prize claims, or Winner Forms or the failure to receive same due to any cause, including without limitation human or technical problems, failures, or malfunctions of any kind, whether originating with Participant, Sponsor, or otherwise, that may prevent or limit any Participant's ability to participate in the Sweepstakes or send or receive messages requiring action or response by such Participant; (b) any computer system, phone line, hardware, software or program malfunctions, or other errors, failures, hacks, unauthorized access, delayed computer transmissions or network connections in connection with the Sweepstakes; (c) any problems or technical malfunction of any network or lines, servers or providers, equipment or software, including any injury or damage to Participant or Participant's property resulting from participation in the Sweepstakes; (d) the awarding, acceptance, possession, use, misuse, loss or misdirection of any Prize or participation in any Prize related activities or any inability of any winner to accept a Prize for any reason; (e) any Participants who do not comply with or who violate the Official Rules or who have committed fraud or deception in participating in the Sweepstakes or in claiming a Prize; or (f) any delays or disruptions as a result of a Force Majeure (as defined herein).
