10' long adjustable bars are available at \$31.80 for each exhibitor supplied track of lights. The length of the adjustable bars range from 2 feet to 10 feet. Please note that if you are ordering more than a 10 - foot section or need freestanding bars, you will need vertical support poles and bases.

Please follow the steps below to order your adjustable bars:

- 1) **INDEMNIFICATION AGREEMENT must be signed and dated. A witness signature must be provided. Any orders received without a signed INDEMNIFICATION AGREEMENT or with an INDEMNIFICATION AGREEMENT missing the required signatures and dates will not be processed and the adjustable bars will not be installed. Orders signed at show site will be charged the show site rate.**
